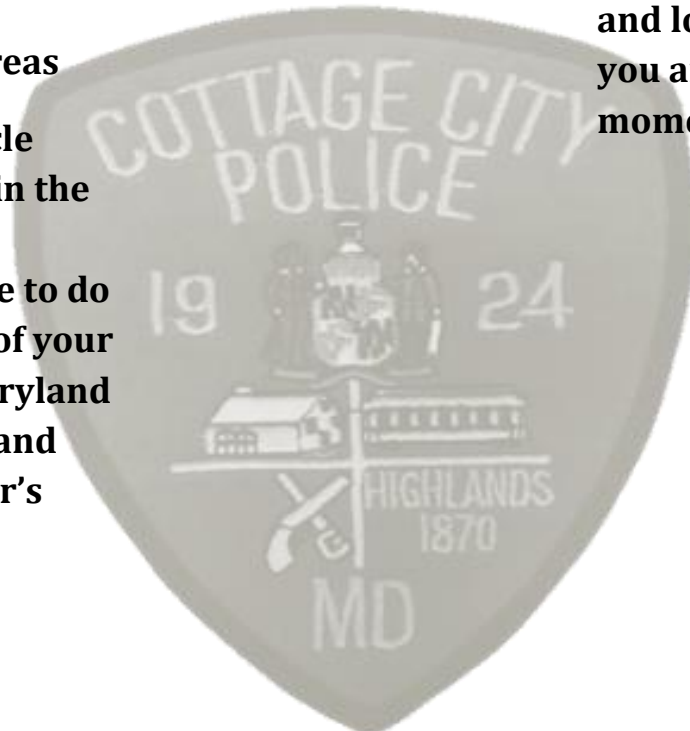
Crime Alert

THEFT FROM AUTO'S

Cottage City and the neighboring jurisdictions have been experiencing a lot of Theft from Auto's. These thefts have occurred during the night time when the visibility is low. We will increase visibility on the days that crimes are high.

Cottage City Police are committed in making the town safe and protecting your valuables. We ask that everyone follow basic safety tips:

- Always lock your doors
- Never leave your keys in your vehicle
- Park in well-lit areas
- Never leave vehicle running and keys in the ignition while unattended, failure to do so results in theft of your vehicle and/or Maryland citation of \$70.00 and one point on driver's license.
- Use more than one anti-theft device
- Keep valuables out of plain view in your vehicle and lock the doors even if you are going inside for a moment
